Alderman Norris made a motion to approve the May 6, 2021, Business Session Minutes. Alderman Ross seconded the motion. All Aldermen voted aye.

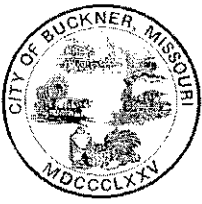
PUBLIC COMMENTS

ELECTED OFFICIAL'S COMMENTS


Alderman Kolle reported that he would like to discuss at an upcoming Board of Aldermen meeting a plan to enforce code violations.
