## Board of Alderman Meeting Minutes

#### CALL TO ORDER

Marty Bears, 107 Park Ave, stated her concerns about flooding issues at her residence.

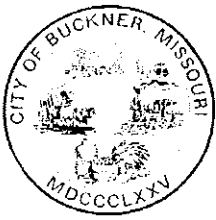
#### OLD BUSINESS

**1. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION regarding City Hall Rental Agreement.**

City Administrator Bobadilla reported that the only change is line# 9 which prohibits religious and political groups from renting City Hall. Alderman Kolle made a motion to approve. Alderman Norris seconded the motion. All Aldermen voted aye.

**2. BILL NO. 22-05 ORDINANCE NO. 1067 AN ORDINANCE AMENDING SECTION 210.760 "NOISE CONTROL" OF THE CITY OF BUCKNER, MISSOURI MUNICIPAL CODE.**

Mayor Box noted a scribbler's error in section 1; line C adding "ing" at the end of operate. Alderman Norris made a motion to suspend the rules and allow for a second reading by title only. Alderman Jones seconded the motion. All Aldermen voted aye. Attorney Mauer read the ordinance by title only for a second time. Alderman Norris made a motion to approve. Alderman Jones seconded the motion. Roll call vote as follows: Alderman Jones, Alderman Walcott, Alderman Norris, and Alderman Kolle voted aye.

**NEW BUSINESS**

**1. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION regarding repairs to pump at Echo Ridge Lift station.**

City Administrator Bobadilla stated that a pump at the lift station needs repaired for the cost of \$9,951.33. The quote from Alliance Pumps was a worst-case scenario it can be reduced if the impeller can be spared. Alderman Kolle made a motion to approve. Alderman Norris seconded the motion. All Aldermen voted aye.

**2. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION regarding the replacement of the clarifier motor at the wastewater treatment plant.**

City Administrator Bobadilla stated that, during last week's thunderstorm, one of the phases of the electrical 3 phase system went out causing the motor at the clarifier to burn out and needs to be replaced. Alderman Norris made a motion to approve the replacement for \$1,765.79. Alderman Kolle seconded the motion. All Aldermen voted aye.

**3. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION regarding the replacement of the UV Air conditioner unit.**

City Administrator Bobadilla stated that air conditioner that is inside the PCI unit of the UV control panel is not working. The a/c unit is outdated, and we can't get parts for it. Alderman Kolle made a motion to approve the replacement in the amount of \$10,513.00. Alderman Norris seconded the motion. All Aldermen voted aye.

**4. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION regarding Tyler's Technologies Credit Card Contract.**

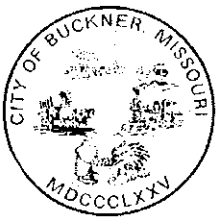
